## 5. Invitations

The Alltech FEI World Equestrian Games 2010 (FEI WEG) are open to all National Federations (NFs) who are members of the Fédération Equestre Internationale (FEI).

If a National Federation does not declare their participation within the previously set entry period, then they may only do so with permission from the FEI and the OC.

**All persons traveling from non-visa waiver countries to the U.S. for the Games must obtain visas. The OC encourages that all visa applications be made to the U.S. as early as possible. For non-visa waiver countries please see [http://travel.state.gov/visa/temp/types/types\\_1262.html#2](http://travel.state.gov/visa/temp/types/types_1262.html#2). (See Annex V)**

## 6. Entries

Nominated and definite entries must be submitted using the HippoBase online entry system. The OC, the FEI and Peden Bloodstock will regard the data supplied online as the only official entry information. Any information sent to the OC by email or fax, which could also be entered directly into the online system, will not be accepted. The FEI will approve participation (certificates of capability) based on qualifying results entered into the system. National Federations who need a user account for their staff members, please see [www.equinis.com/Hippobase/Login](http://www.equinis.com/Hippobase/Login). The Games will be accessible to NFs in HippoBase only after the OC has received and approved the entry in principle. The NFs must designate and provide contact information for the person responsible for submitting entry fee payments. The OC will not accept incomplete entries.

### **PIRO Positive Horses Must Be Declared in HippoBase**

### **Entries in Principle: May 1, 2010**

Each NF must declare whether they plan to participate with a team and/or individual athletes in each of the eight respective disciplines. The Entries in Principle should be submitted by fax (859-389-8740) or email (sport@feigames2010.org) by May 1, 2010. **See Annex III.**

### **Nominated Entries: August 16, 2010**

Detailed entries with all complete information are required. According to GR Art. 116.4.2, the list of the Nominated Entry may consist of a higher number of athletes and horses than the Definite Entry.

<b>CH-M-R/Reining</b>	<b>August 16, 2010</b> Each NF may enter a maximum of 10 athletes and 10 horses.
<b>CH-M-E/Endurance</b>	<b>August 16, 2010</b> Each NF may enter a maximum of 10 athletes and 12 horses.
<b>CH-M-D/Dressage</b>	<b>August 16, 2010</b> Each NF may enter a maximum of 8 athletes and 8 horses.
<b>CH-M-C/Eventing</b>	<b>August 16, 2010</b> Each NF may enter a maximum of 18 athletes and 18 horses.
<b>CH-M-S/Jumping</b>	<b>August 16, 2010</b> Each NF may enter a maximum of 10 athletes and 20 horses.
<b>CH-M-P/Para-Dressage</b>	<b>August 16, 2010</b> Each NF may enter a maximum of 14 athletes and 14 horses. The host NF is allowed to nominate an additional 6 athletes and 6 horses.
<b>CH-M-V/Vaulting</b>	<b>August 16, 2010</b> Each NF may enter a maximum of 2 teams of 7 vaulters plus 2 longeurs and 2 horses per team and a maximum of 8 female and 8 male vaulters plus 2 longeurs and 2 horses per individual vaulter.
<b>CH-M-A/Driving</b>	<b>August 16, 2010</b> Each NF may enter a maximum of 6 athletes and 30 horses. The host NF is allowed to nominate an additional 6 athlete and 30 horses.



### **Certificate of Capability**

Certificates of Capability must be sent to the FEI and the OC by August 16, 2010 for all disciplines except Endurance (Art. 816.3.13). Endurance Certificates of Capability are due to the FEI by July 27, 2010. Official FEI publications serve as the source for the qualification criteria that each athlete and horse must meet in order to compete. The FEI confirms a Certificate of Capability for every athlete and horse. *Vaulting is the sole discipline where only vaulters have to qualify.*

### **Definite Entries:**

The names of the athletes and horses actually starting must be indicated and selected from those athletes and horses on the Nominated entry list.

<b>CH-M-R/Reining</b>	<b>Monday, September 20, 2010</b> Each NF may enter a maximum of 5 athletes and 5 horses (or up to 2 individual athletes with 1 horse each).
<b>CH-M-E/Endurance</b>	<b>Tuesday, September 21, 2010</b> Each NF may enter a maximum of 5 athletes and 6 horses (or up to 2 individual athletes with a maximum of 1 horse each).
<b>CH-M-D/Dressage</b>	<b>Wednesday, September 22, 2010</b> Each NF may enter a maximum of 4 athletes with 1 horse each (or up to 2 individual athletes with 1 horse each).
<b>CH-M-C/Eventing</b>	<b>Saturday, September 25, 2010</b> Each NF may enter a maximum of 6 athletes with 1 horse each (or up to 2 individual athletes with 1 horse each).
<b>CH-M-S/Jumping</b>	<b>Wednesday, September 29, 2010</b> Each NF may enter a maximum of 5 athletes with 1 horse each (or up to 2 individual athletes with 1 horse each)
<b>CH-M-P/Para-Dressage</b>	<b>Thursday, September 30, 2010</b> Each NF may enter a maximum of 7 athletes with 1 horse each (or up to 2 individual athletes with 1 horse each). The host NF is allowed an additional 3 individual athletes with 1 horse each.
<b>CH-M-V/Vaulting</b>	<b>Friday, October 1, 2010</b> Each NF may enter a team of 7 vaulters, 1 horse and 1 longeur. They may also enter a reserve longeur and reserve horse. Each NF may enter a maximum of 3 individual females and 3 individual male vaulters, 1 longeur and 1 horse per individual vaulter. They may also enter one male individual reserve and one female individual reserve vaulters (No individual reserve horses or longeurs).
<b>CH-M-A/Driving</b>	<b>Saturday, October 2, 2010</b> Each NF may enter a maximum of 3 athletes with a maximum of 5 horses each (or 1 individual athlete with a maximum of 5 horses). The host NF is allowed an additional 3 individual athletes with 5 horses each.

**Additional horses not officially participating in the FEI WEG will not be allowed entry to the Kentucky Horse Park grounds.**

## **7. Substitutions**

According to General Regulations article 116.4.2, nominated entries ... must include a list of the names of Athletes and Horses from which the Definite Entries and any substitutions will be chosen and state the number of athletes and horses which the NF intends to send.

In the event of an accident or illness of an athlete and/or horse, substantiated by a certificate from an officially recognized doctor and/or veterinarian, between the date of definite entries and at the latest one hour before the first horse inspection, substitutions of athletes and/or horses can be made. Such substitutions must be taken from the updated list of the NF's nominated entries and require Ground Jury approval. For Eventing please also refer to Art. 510.4. For Endurance please also refer to Art. 828.3. For Reining refer Art.305. For Vaulting refer Art 710. For Para-Dressage please also refer to Art. 8424. For Jumping please refer to Art. 304.2 in the Rules for Jumping Championships and Olympic Games 23<sup>rd</sup> edition. For Dressage, please refer to Art. 423.

## **8. Entry Fees:**

Entry fees must be paid by September 1, 2010 in U.S. Dollars by all respective NFs for all horses, including reserve horses. A \$15 (USD) equine drug testing fee for each horse must be submitted with the entry fee payments. **(See Annex III)**

## General Conditions

Rules for Participation: For further information, see under respective discipline.

As soon as NFs have presented their entries, all Chefs de Mission, Chefs d'Equipe, athletes, also on behalf of the horse owners, as well as their employees/grooms, representatives and accompaniments are requested, upon arrival at the venue, to acknowledge and keep within the FEI Code of Conduct and all applicable FEI rules and regulations, including but not limited to the Equine Anti-Doping and Controlled Medication Regulations, as well as to behave according to ethical principles in common practice. Violations will be dealt by the respective Ground Jury or Appeal Committee. All athletes and Chefs d'Equipe must sign the Code of Conduct and Athlete Waivers. Chefs d'Equipe are required to submit the signed copies of the Code of Conduct and Athlete Waivers to the Secretariat upon arrival. **(See Annex I and II)**

## Code of Conduct

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horse and athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their area of expertise.

The OC reserves the right, to make use of all illustrations (photographs, images, videos, etc.) made on behalf of the OC during the event or on the show grounds for their commercial purposes, without the explicit consent of the person/athlete illustrated.

## 9. Venue

The Alltech FEI World Equestrian Games will take place on the grounds of the Kentucky Horse Park, Lexington, Kentucky, USA. The Endurance trail will travel through 23,000 acres of adjoining Kentucky countryside.

### Training Areas

Practice arenas and practice obstacles will be available to athletes on the competition site according to a time table. Riding, driving, or vaulting outside these arenas and areas and outside scheduled times is not permitted. The training areas will be controlled by stewards. Dimensions of the training areas:

**Liability**

The OC declines any liability for property or pecuniary damage which may happen to visitors, athletes, grooms and horse owners through slight negligence of the OC, his delegates or his assistants. The OC also declines any liability for theft, fire or other incidents.

By making the definite entries each athlete declares that he/she has taken notice of the schedule and exclusion of the liability as set out in the schedule and that the athlete explicitly agrees therewith. All athletes are required to sign the waiver and Chefs d'Equipe are required to submit the form to the Secretariat upon arrival. **(See Annex II)**

**Insurance**

All Chefs de Mission, Chefs d'Equipe, athletes, owners, trainers, team veterinarians and their accompaniments are personally responsible for damages to third persons caused by themselves, their employees/grooms, their agents or their horses. They are therefore strongly advised to take out a third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep policy up to date. The OC/FEI will NOT be responsible for any damage caused by athletes, their horses, NF officials, their employees/grooms or their representatives.

The horses competing in the Jumping Final are insured on standard conditions, death and loss of use for \$1 million per horse. This policy is a partial insurance coverage for these horses. If the owners wish to have their horses covered for a greater sum they should take out an additional insurance policy themselves.

Medical, veterinary and farrier services will be available on the venue from September 10, 2010 through October 11, 2010. Services are provided at the athlete/NF's expense.

**10.3.1 Influenza**

All horses must be verifiably vaccinated according to FEI Equine Influenza Regulations (Veterinary Regulations, Annex VI).

**10.3.2 Other Recommended Immunizations**

The Kentucky State Veterinarian Dr. Robert Stout and Dr. Kent Allen, World Equestrian Games Veterinary Coordinator, recommended that all National Federations give serious consideration and implement strategies to insure their horses have established immunities against the following diseases:

1. Eastern Equine Encephalitis
2. Western Equine Encephalitis
3. West Nile Virus
4. Equine Herpes Virus – Type I

All such vaccinations should be recorded on the horse's individual passport or accompanying health certificate.

#### **10.4 Control Plan for Piroplasmosis-Positive Horses at the 2010 Alltech FEI World Equestrian Games (WEG) at the Kentucky Horse Park**

This control plan was developed cooperatively by the 2010 WEG Foundation, Kentucky Department of Agriculture, and USDA Animal and Plant Health Inspection Service (APHIS) to manage all horses positive to equine piroplasmosis that will participate in competition events during the 2010 Alltech FEI World Equestrian Games at the Kentucky Horse Park (KHP) in Lexington, Kentucky. The control plan outlines specific requirements for piroplasmosis-positive horses to participate in the 2010 WEG and describes the control and monitoring plan to minimize the transmission of equine piroplasmosis to domestic horses.

##### **Identification, pre-export de-worming and quarantine of piroplasmosis-positive horses**

1. Space will be reserved in dedicated stables for piroplasmosis-positive horses only.
2. Piroplasmosis-positive horses must be identified by the participating National Federations before presentation to the United States for entry.
  - All piroplasmosis-positive horses must be listed on the Application for Import or In Transit Permit (VS Form 17-129) and will be listed on the U.S. Department of Agriculture Permit to Import (VS Form 17-135) issued by the National Center for Import and Export prior to shipment.
  - National Federations must identify every Piroplasmosis-positive horse on the Hippobase Entry System in the space provided when Nominated Entries are submitted.
  - National Federations may be assessed a \$1,000 (USD) processing fee by WEG authorities if horses arrive at the WEG quarantine without a previous declaration for piroplasmosis and are subsequently found to be positive for piroplasmosis.
  - Additionally, horses may be delayed exit from quarantine and will only be admitted to the piroplasmosis-positive horses stable. All horses previously turned out together, or closely associated with a newly discovered piroplasmosis-positive horse, will undergo further testing and may be delayed exit from quarantine.
3. To assist in preventing the introduction of ticks to the KHP, APHIS will require every horse in the WEG to be administered a de-wormer containing ivermectin, doramectin, or moxidectin at a dose rate not less than 200 mcg/kg body weight during the 2- to 4-week period preceding entry to the KHP. Acceptable ivermectin products include many that are approved for use in de-worming horses. The approved de-wormer will be administered by the National Federation's team veterinarian or, if necessary, by piroplasmosis-positive horse quarantine personnel or other designated veterinary personnel.  
In each case, certification of the de-worming will be made by the administering official's signature on approved certificates.  
Horses will be detained and immediately de-wormed by the appropriate veterinary personnel if they arrive without this required de-worming certification.
4. Piroplasmosis-positive horses will not be allowed entry into the United States prior to the opening of the piroplasmosis-positive horse stables at the KHP unless they are completing APHIS quarantine requirements and subsequently proceed directly to the piroplasmosis-positive horse stables when released from import quarantine.



## Management of piroplasmosis-positive horses at the KHP

1) All horses entering the piroplasmosis-positive horse stables will be treated with an acaricide product at the import quarantine center or immediately upon arrival at the piroplasmosis-positive horse stables.

Re-application will occur according to label instructions or as prescribed by APHIS and Kentucky Department of Agriculture veterinary staffs.

All horses will undergo inspection for ticks upon entry or re-entry into the piroplasmosis-positive horse stables, including inspections after exercise, training, competition, or any other entry/exit from the stables.

2) When outside the stables, piroplasmosis-positive horses will have a unique identifier, e.g., a color on their numbers, and will only exercise in FEI-stewarded areas, including exercise prior to the commencement of the WEG.

Additionally, the piroplasmosis-positive horses may require acaricide treatment before exiting the stables. Piroplasmosis-positive horses will not be permitted to graze in any area other than the designated grazing area for piroplasmosis-positive horses.

Any piroplasmosis-positive horse observed outside of this designated area by FEI stewards or other authorized personnel will be required to immediately return to the piroplasmosis-positive horse stables. These horses will be inspected and may be required to undergo treatment for ticks before entering the stable. Additional appropriate actions may be implemented.

3) Piroplasmosis-positive horses should be exported from the United States within 10 days after their competition and must be exported by the closing date of the piroplasmosis-positive horse stables at the KHP.

Exceptions will only be made upon consultation and approval by appropriate APHIS personnel.

**NOTE: As of January 15, 2010, the Kentucky Department of Agriculture has determined that all horses entering the Kentucky Horse Park will need a negative Piroplasmosis test taken sometime during 2010. This will include all domestic, North American and demonstration horses that did not previously have this requirement.**

### 10.6 Equine Drug Testing

Elective testing (FEI Form 4) will be available to the teams and individuals during Quarantine at Cincinnati and on the grounds at the WEG. The athletes will be charged a fee of \$15.00 per horse toward the costs of the above program. This fee should be submitted with the entry fee.

## **11. Equine Services**

### **11.1 Opening of Venue**

The Kentucky Horse Park venue opens September 10, 2010. The arrival of horses to the venue will be dependant on length of time spent in quarantine, length of time in the United States and the discipline in which they are competing.

### **11.2 Arrival Procedures (See Annex VI for further information)**

Equine participating in the Games are required to be imported to the United States in accordance with the requirements established by the United States Department of Agriculture.

For participation in WEG, USDA will be extending CEM Waivers and allowing horses testing equine piroplasmosis positive to import with restriction. In addition to the permanent importation centers operated by USDA in Miami, New York and Los Angeles; the World Equestrian Games is establishing a temporary import center to operate under USDA supervision at the Cincinnati Northern Kentucky International Airport. With the exception of horses importing from countries not recognized by the USDA as being free from VEE or screwworm, federations may import through the Northern Kentucky Center during the times it is operational. Horses from VEE or screwworm infested countries are required to be quarantined for a minimum of 7-days and will be completing their quarantine at the Miami Animal Import Center.

**Horses importing through Miami or Los Angeles:** The organizer will work with federations required to import through Miami or Los Angeles to schedule the importation and transportation from Miami or Los Angeles to Lexington by air transport.

**Horses importing through New York:** The organizer will work with the federations to schedule these horse's importation and transportation from New York to Lexington by ground transport.

**Horses entering into the U.S. from Canada:** Horses entering the United States from Canada less than 60 days before the Games must meet the following requirements:

Must be accompanied by an original copy of export health certificate from country of origin. If original is not available, a copy endorsed by Canadian government veterinary officials is acceptable.

Must be accompanied by certification from Canadian government veterinary officials that horses have been tested for Dourine, Glanders, Equine Infectious Anemia, Piroplasmosis, and have been released from quarantine.

Horses must meet U.S. Contagious Equine Metritis, (CEM) protocol and be accompanied by documentation certifying to the testing. If not, they will be under the CEM waiver program.

Horses coming from Canada into the US during the Games period, September 10, 2010 through October 10, 2010, will be required to fly into the Cincinnati Airport and be met by USDA, cleared and then transported to the venue by horse van. Any NF whose horses arrive to the U.S. from Canada prior to the Games period must coordinate arrival with the USDA and will be obligated to pay any and all user fees. All Piroplasmosis positive horses will be required to enter the United States through a USDA approved port of entry Quarantine center. Quarantine sites for the 2010 Games are: Cincinnati/Northern Kentucky Airport KY, Miami Airport FL, New York Airport NY, Los Angeles Airport CA.

**All arrivals must be scheduled with the OC.**

**Horses may not be unloaded without the authorization of the Stable Manager.**

### **Health Certificate**

At the time of the first examination, i.e. upon arrival of the horses on the show grounds and before entering the stables, every athlete is required to have on hand the health certificates and supporting documents required for the transport to the event and admittance to the stabling area.

All horses must be verifiable vaccinated according to FEI Equine Influenza Regulations (Veterinary Regulations, Annex VI).

To assist in preventing the introduction of ticks to the KHP, APHIS will require every horse in the WEG to be administered a de-wormer containing ivermectin, doramectin, or moxidectin at a dose rate not less than 200 mcg/kg body weight during the 2- to 4-week period preceding entry to the KHP.

Acceptable ivermectin products include many that are approved for use in de-worming horses. The approved de-wormer will be administered by the National Federation's team veterinarian or, if necessary, by piroplasmosis-positive horse quarantine personnel or other designated veterinary personnel.

In each case, certification of the de-worming will be made by the administering official's signature on approved certificates.

Horses will be detained and immediately de-wormed by the appropriate veterinary personnel if they arrive without this required de-worming certification.

*See sections 7.3 and 7.4 for more information.*

The certificate must be issued in at least one official language of the country of destination and in one official language of the member country. The athlete must carry with him the original certificate, not a copy.

Horse passport and veterinary documents – including the health certificates for horses from foreign countries – are to be submitted to the official show veterinarian immediately after the arrival of the horses on the venue. These documents will also be handed back at the office of the official veterinarian – after payment of all expenses.

The organizer sees to it that on the competition site, a USDA accredited veterinarian is present to issue health certificates which are necessary for the transport of the horses to their destination abroad.

### **11.3 Departure Procedures**

Export requirements are set by the country of destination and are negotiated with USDA APHIS VS National Center for Import Export (NCIE). The negotiated certification protocols for each country are listed at the following URL address: <http://www.aphis.usda.gov/regulations/vs/iregs/animals/>.

Most countries require an import permit for each shipment. The import permit should be obtained from the country of destination as early as possible to ensure import requirements can be met.

Import requirements (IREgs and Import Permit) should be reviewed for destination country. Accredited veterinarian (WEG veterinarian) will examine the animal and review all required documents (test results, vaccination letters, and import documents). Special attention should be given to test dates. Depending on length of stay, additional testing may be required. Export certificates are to be completed by the accredited veterinarian and delivered to USDA APHIS VS import/export staff for review and endorsement.

After endorsement of export certification documents, horses can be transported to their point of departure.

All accounts with the World Equestrian Games 2010 Foundation, Inc. and its partners must be settled at the Secretariat prior to departure. This includes charges for farrier or veterinary services, feed, hay, bedding, etc.

**Passports will not be returned until all accounts with the World Equestrian Games 2010 Foundation, Inc. and its partners are settled.**

### **12. Feed, Hay and Bedding (See Annex VII for further information)**

The United States Department of Agriculture will not permit the import of hay with viable seeds into the United States. Top quality hay will be provided. U.S. and Canadian horses may not bring their own hays due to the Piroplasmosis requirements.

**Horses will be stabled by discipline.**

**Additional horses not officially participating in the FEI WEG cannot be brought to the venue.**

### **13. Storage of Equipment and Supplies**

#### **13.1 Tack Stalls**

The OC will provide tack stalls according to FEI requirements. Additional tack stalls may also be available.

#### **13.2 Shipping Containers**

Shipping containers must arrive on the venue by Monday, September 20, 2010. Advance notice of shipment must be made to Venue Logistics. Once unloaded, the containers will be stored off-site.

#### **13.3 Rental Vendors**

If there is sufficient interest, rental of barn supplies will be available. (See Annex IV)

Back numbers for Driving will be distributed in the Chef's Meeting scheduled for Friday, October 8, 2010. Bib numbers for Endurance will be distributed in the General Meeting scheduled for Friday, September 24, 2010.

## **16.2 Partners**

## **16.3 Hotel Accommodation for Additional Delegation Members**

- a) Limited accommodation at the expense of the NF or at one's own expense will be provided for persons other than those belonging to the official team (For example: veterinarians, medical doctors, physiotherapists, psychologists, farriers, etc). Fulfillment of such requests depends on the availability of accommodation. Previous payment at one's own expense directly to the hotel will be required.
- b) However, it will not always be possible to accommodate these persons in the same hotel as the official team members.
- c) Earliest arrival and latest departure dates according to the dates specified for the official team members.
- d) Such requests must be received by the OC as early as possible and at the latest according to the declaration deadlines.

## **16.4 Declarations**

- a) All reservations as stated above (section 14.1 through 14.3) will be made by Short's Sports and Event Logistics on behalf of the OC.
- b) The OC must receive the declarations (number of rooms for team members, number of rooms for additional officials, type of rooms, arrival date, and departure date) for this purpose according to the following declaration deadlines:

-Preliminary declarations	before December 1, 2009
-Definite declarations	before May 1, 2010
-Preliminary name list	before May 1, 2010
-Definite name list	with the definite entry, according to discipline
- c) Changes regarding the number of hotel rooms cannot be accepted after the definite declarations.
- d) National Federations not keeping to this schedule risk that their team officials will not be accommodated by the OC at their hotel of choice.

## **16.5 General Conditions**

- a) For accommodation provided free of charge by the OC, the OC will only cover the room expenses if the room is personally used by the persons stated under General Regulations Article 131.
- b) Everyone must pay any additional costs (phone, mini-bar, parking, etc.) directly to the hotel before departure. Therefore, all guests (including those staying at the expense of the OC) must present their credit card upon checking in at their hotel.
- c) Anyone needing accommodation before or after the period free of charge as stated above can request this through the Short's Sport and Event Logistics (see GR 131) within the above stated declaration dates. Fulfillment of such requests depends on the availability of accommodation. Previous payment at one's own expense directly to the hotel will be required.
- d) Athletes not wishing to make use of the hotel reservation as made by the OC will receive no total or partial reimbursement for unused accommodation.

e) The OC will charge the concerned National Federation with all the relevant costs (i.e. cancellation and no-show fees) involved for anyone, for whom the OC has made reservations according to their request received with nominated entry, deciding to stay in another hotel, or who does not accept the rules of the assigned accommodation, and there will be no refund of any advanced payment.

\*Food will be available for purchase on venue for the entire Games period (September 10, 2010 through October 11, 2010).

*All meals for Athletes and Grooms will be on the Kentucky Horse Park grounds in the Athletes Restaurant*

## **19. Transportation**

### **19.1 Shuttle Service**

Chefs de Mission, Chefs d'Equipe, athletes, veterinarians and trainers will be greeted at the airport with their assigned vehicle and driver. Based on the size of the NF delegation, each team will have their own assigned vehicle(s) and driver(s). This driver will transport the group to and from the hotel during the competition.

### **19.2 Parking Passes**

The assigned team vehicle(s) will have their own entrance and parking at the venue. Limited parking passes will be available for purchase by NFs for additional parking at the venue.

### **19.3 Grooms Shuttle**

A shuttle will be provided between the Grooms Village and the Barns on a 24 hour basis. During daytime hours, a shuttle will run at regular intervals from the groom's village to the barns. At night, shuttles will be on call. One shuttle will be staged at the Grooms village and one shuttle at the barns and each will run as needed. A time schedule for the shuttle will be provided.

## **20. Reimbursement of Travelling and Transportation Expenses (GR Art 131 )**

The OC will provide a travel allowance to all teams shipping horses overland to the venue within the Games period (September 10, 2010 through October 10, 2010).

## **21. Settlement of Accounts**

**Reimbursement of prize money, transport and traveling expenses** will be paid out **by bank transfer from the OC** only to the respective NFs by October 18, 2010. For this purpose the NFs are requested to state their bank information (name of recipient, bank name, bank code, account number, IBAN and BIC codes) in the form in **Annex III**. The NFs will receive receipts for the settlement of account per athlete by regular mail.

**Passports will not be returned until all accounts with the World Equestrian Games 2010 Foundation, Inc. and its partners are settled.**

## **22. Protests according to Art 163**

Protests may be lodged by Presidents of NFs, Officials, Chefs d'Equipe or, if a Chef d'Equipe is not present, by a Person Responsible or a Team Veterinarian responsible for horses taking part in the Event, with the exception of protests for abuse which may be lodged by any person or body.

An arbitration procedure is provided for under the FEI Statutes, 22<sup>nd</sup> Edition November 2008 and the FEI General Regulations, 23<sup>rd</sup> Edition 2009. In accordance with this procedure, any appeal against a decision rendered by the FEI or its official bodies must be settled exclusively by the "Court of Arbitration for Sport" (CAS) in Lausanne, Switzerland.

## **23. Event Organization (Art 109 and 110)**

In exceptional circumstances, together with the approval of the Chefs d'Equipe, host NF delegate, if any, and the Ground Jury, the OC may change the schedule in order to clarify any matters arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all athletes and officials as soon as possible and they must be reported to the FEI Secretary General by the President of the Ground Jury.

## **24. Cancellation of the Event**

If special circumstances demand it, the OC reserves that right to take all necessary actions including the cancellation of the event by repaying the entry fee, with the approval of the FEI.

## **25. Sponsor Logo (Art 135)**

The OC authorizes the athletes to carry the "Logo" of their personal sponsor on their clothing, saddle cloth or carriage (Art 135.2), except in team competitions. In the team competitions only the national logo and the sponsor logo of the national team are permitted. The Chief Steward is responsible for ensuring that FEI Regulations relating to Art 135 are respected by athletes before entering the arena. Athletes not complying with Art 135 will not be permitted to enter the arena during competition. See Art. 521.10 (2010 Rules for Eventing) and relevant discipline rules.

**26. Athletes whose horses leave the venue without permission of the OC during the Games (from the first horse inspection until after the announcement of the results of the last competition) will be disqualified.**

## **27. Horse Vans**

There may be a limited number of spaces to park athlete horse trailers for the duration of the respective disciplines. These spaces will be allocated provided the Organizing Committee has received a request prior to the closing date of the definite entry. These spaces can be used to store athlete horse vans ONLY; under no circumstances can these spaces be used as overnight living/sleeping quarters.

## **28. Stable Security (Vet Regs Art 1005.2.5)**

The following security regulations of the Fire Department must be obeyed:

- Smoking is strictly prohibited in the entire stable area.
- Open fires (e.g. camping stoves) are strictly prohibited.
- Only the actually needed amount of feed supplies may be stored in the stables.
- Open space and entry ways between the stables may not be obstructed by trucks or vans.
- All electrical plugs must be three-pronged.
- No one is allowed to stay in the stables overnight due to the local fire ordinance.

*Those who disregard the above security regulations will incur a fine levied by the OC.*

**29. DOGS (AND ALL OTHER PETS) ARE STRICTLY PROHIBITED ON THE ENTIRE VENUE AS WELL AS THE CROSS-COUNTRY, MARATHON AND ENDURANCE COURSES AND THE KENTUCKY HORSE PARK CAMPGROUND.**

**30. Use of golf carts and bicycles on venue**

A limited number of golf carts will be available for rental to NFs based on the size of their delegation. No personal golf carts may be brought to the venue. Bicycles will also be available on the grounds to rent. Personal bicycles are permitted on the venue.

*Golf Carts and Bicycles must adhere to the designed vehicle routes.  
No other personal motorized transport will be permitted on the venue.*

**31. Chefs' Working Room**

The OC will provide one working room (40 person workspace) for all Chefs de Mission and Chefs d'Equipe. The room will have internet access.

**32. Ceremonies**

**32.1 Opening Ceremony**

All athletes present on the venue at the time of the Opening Ceremonies are invited to participate in the Opening Ceremonies on September 25, 2010 from 19:00 to 21:00.

**32.2 Closing Ceremony**

All gold medallists are requested to be present, at the NFs expense, for the Closing Ceremonies on October 10, 2010 from 16:00 to 18:00. All athletes are welcome to participate.

**32.3 Medal and Prize-Giving Ceremonies**

The medal ceremonies for the FEI World Championships will take place immediately following each competition (except Endurance and Vaulting) and will include only the medal winners (except the Jumping Final: all 4 finalists) with their winning horses, including the lap of honor.

All medallists (individuals and teams) must take part in the official medal ceremonies. All Medallists, except for vaulters, are expected to be mounted or with carriages, in keeping with the tradition of the sport, for the medal ceremonies as part of accepted FEI protocol.

**32.5 Additional Presenting Ceremonies**

Following the official prize-giving ceremonies, the OC on behalf of the Mayor of Lexington requests that all medallists (individuals and teams) take part in additional presenting ceremonies and celebrations in the City of Lexington (according to the schedule). **(See Annex X)**

**32.6 Mixed Zone, Press Conferences, Interviews and Autograph Sessions**

All Chefs de Mission, Chefs d'Equipe, athletes, team officials and especially medallists and placed riders must be available for interviews and autograph sessions when requested by the OC.

**32.7 Kiss & Cry Areas**

Each stadium has a so-called "Kiss and Cry" area to which a maximum of 4 persons pertaining to the relevant athlete currently in the arena will be allowed.

### **33. National Federation Hospitality**

The National Federation's Tent is located adjacent to the hospitality compound near the Main Stadium. Information regarding access to the National Federation's Tent will be sent by the United States Equestrian Federation, beginning in January 2010, to Federations who have indicated they are planning to send teams. Access Passes will be available to purchase or for each of two sessions. Session I provides access from Saturday September 25 – Sunday, October 3 and includes Reining, Endurance, Dressage, and Eventing. Session II spans from Monday October 4 – Sunday, October 10 and includes Jumping, Para-Dressage, Vaulting, and Driving.

**THE FEI CODE OF CONDUCT for the Welfare of the Horse**

The Fédération Equestre Internationale (FEI) requires all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences. This includes adherence at all times to the Equine Anti-Doping and Controlled Medication Regulations.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.

The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.

I further agree and warrant that if, at any time, I believe the conditions to be unsafe, I will immediately discontinue further participation and report such unsafe conditions to WEG officials. I AGREE to release the Fédération Equestre Internationale ("FEI"), the United States Equestrian Federation ("USEF"), the World Games 2010 Foundation, Inc., and the Kentucky Horse Park, as well as all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations, sponsors, advertisers, owners and lessors of any premises as well as any and all event participants ("Released Parties") from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Released Parties. I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the conditions of the grounds on which WEG takes place and the negligence of the Released Parties. There may be OTHER RISKS either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR ANY LOSSES, COSTS, AND DAMAGES I incur as a result of such risks. I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Released Parties and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the WEG. Peden Bloodstock is responsible for the management, coordination and provision of all equine transport services and ground logistics for the Games. This will include but is not limited to coordinating the shipment & quarantine arrangements for all horses, their attendants, equipment and carriages to and from Lexington.

### **Costs covered by the WEG OC**

The WEG OC is liable to cover the costs for all qualified horses arriving and departing inside the arrival & departure windows in the USA as follows:-

All landed & handling charges at the port of arrival  
Post arrival quarantine and all import related formalities  
Trucking from the arrival airport, via quarantine directly to and from the Kentucky Horse Park  
All export & handling charges at the port of departure  
USDA costs for return health certification  
A trucking allowance to the Kentucky Horse Park will be made for all horses resident in North American and qualified to compete at the WEG

The above local costs in the USA will only be covered by the OC if the arrangements are coordinated by our Official Shipping Agent, Peden Bloodstock.

### **Costs covered by NFs**

Each NF is responsible for the following costs related to the transport of their horses, attendants & equipment to and from the USA.

#### **1. Horses**

All CIF (cost, insurance & freight) costs from the country of origin up to USA airport  
All costs from “FOB” (free on board) USA airport to country of origin  
All pre export quarantine charges in the USA if required by the country of destination  
All pre export blood testing related costs if required by the country of origin

#### **2. Equipment**

All costs from point of origin up to delivery to the Kentucky Horse Park  
All costs from the Kentucky Horse Park up to point of destination

#### **3. Attendants**

All flight, visa and accommodation costs to and from the Kentucky Horse Park. Details of the costs for accommodation at the venue are covered separately by the OC.

### **Port of entries to the USA and post arrival quarantine (PAQ)**

There are 4 official points of entry for horses to the United States for the WEG in 2010, Cincinnati, Miami, Los Angeles & New York. Horses are not permitted by the United States authorities to arrive at any other airports in the USA.

### **Cincinnati**

Cincinnati airport is located approximately 120kms North of the Kentucky Horse Park and is the preferred point of entry of all competing horses originating from the European Continent and the Middle East due to its close proximity to the venue.

The OC has invested vast resources to construct a unique post arrival quarantine facility directly adjacent to the airport specifically for the WEG ensuring the shortest possible driving distance for horses to and from the Kentucky Horse Park, thereby reducing the total transit time for the majority of competing horses who will be originating from the European Union.

It is crucial to note that a limited number of grooms/attendants will have access to their horses during the two day PAQ period and will be permitted to hand walk them in the stable area.

On the completion of PAQ all horses will be trucked approximately 90 minutes to the Kentucky Horse Park.

### **Miami**

Miami airport will be the point of arrival for all horses entering the USA from South America. A modern PAQ facility is located adjacent to the airport and grooms/attendants will have limited access to their horses during the two, respectively seven day PAQ period

On the completion of PAQ a charter flight will be organised for all horses from Miami to Lexington. Dates of the charter flight will be confirmed to all NFs with qualified horses and it is each NFs responsibility to ensure that they coordinate their flights to Miami with Peden Bloodstock to connect with the charter flight to Lexington having completed their PEQ.

### **Los Angeles**

Los Angeles airport will be the point of arrival for all horses entering the USA from Australasia. The PAQ is located in close proximity to the airport but grooms/ attendants will not have access to their horses during the PAQ period.

On the completion of PAQ a charter flight will be organised for all horses from Los Angeles to Lexington. Dates of the charter flight will be confirmed to all NFs with qualified horses and it is each NFs responsibility to ensure that they coordinate their flights to Los Angeles with Peden Bloodstock to connect with the charter flight to Lexington having completed their PEQ.

### **New York**

John F. Kennedy (JFK) airport will be the point of arrival for those NFs who choose not to fly their horses of European origin directly to Cincinnati. On arrival all horses will be trucked to the PAQ at Newburg which is located approximately 1.5 to 2 hours north of New York. Grooms/ attendants will not have access to their horses during the two day PAQ period.

On the completion of PAQ all horses will be trucked approximately 12-14 hours (depending on traffic conditions) from Newburg to Lexington, Kentucky.

### **Arrival & Departure windows**

The following are the arrival & departure windows in the USA. During these windows the OC will cover all costs as laid out above in the section Costs covered by the WEG OC

Reining, Dressage, Endurance & Eventing

Cincinnati	– Arrival window opens for the first arrivals on the 16.09.2010
Miami	– Arrival window opens for the first arrivals on the 1.09.2010
Los Angeles	– Arrival window opens for the first arrivals on the 14.09.2010
New York	– Arrival window opens for the first arrivals on the 16.09.2010

The venue stables will close on the **5<sup>th</sup> October** for the above disciplines except Reining. Reining horses based in the United States are requested to leave by 12pm on October 1, 2010 in order to accommodate incoming vaulting horses.

Driving, Jumping, Para Equestrian & Vaulting

Cincinnati – Arrival window opens for the first arrivals on the 23.09.2010  
Miami – Arrival window opens for the first arrivals on the 16.09.2010  
Los Angeles – Arrival window opens for the first arrivals on the 21.09.2010  
New York – Arrival window opens for the first arrivals on the 23.09.2010

The venue stables will close on the **14<sup>th</sup> October** for the above disciplines.

#### **Piroplasmosis positive horses**

Piroplasmosis positive horses will be permitted entry to the USA specifically for the WEG. These horses being imported for the Games must be shipped directly to the Kentucky Horse Park after clearing quarantine and must be re-exported directly from the Kentucky Horse Park after the Games.

#### **The following domestic transfers in the USA are permitted by the United States Department of Agriculture for Piroplasmosis positive horses:**

1. Cincinnati airport – Kentucky Horse Park – Cincinnati airport (by road)
2. Miami airport – Kentucky Horse Park – Miami Airport (from Miami airport to/from Lexington airport by air organised by Peden and paid for by the OC)
3. Los Angeles airport – Kentucky Horse Park – Los Angeles Airport (from Los Angeles airport to/from Lexington airport by air organised by Peden and paid for by the OC)

Piroplasmosis positive horses will not be permitted to enter or exit the United States via any of the New York airports.

Further details of all transport & logistic arrangements will be forwarded to all NFs in November 2009 in the Equestrian Freight Manual.

## **Annex VII      Feed, Hay and Bedding**

### **Feed, Hay and Bedding Supplier for the 2010 Alltech FEI World Equestrian Games**

Kentucky Equine Research (KER) has been contracted by the World Games 2010 Foundation to supply forage, feed and bedding to the National Federations (NF) participating in the 2010 Alltech World Equestrian Games in Lexington, Kentucky. KER has provided a similar service at the last four Olympic Games. KER will offer an assortment of hays, cereal grains, concentrate feeds, supplements and bedding materials which are of superior quality and which are designed for performance horses competing in the eight disciplines represented at WEG 2010.

The various products will be offered as a **complete, all-inclusive package**.

**Package cost:** The cost of the all-inclusive package is USD\$35/horse/day. Horse days will be calculated from the day that the horse arrives at the Kentucky Horse Park (the venue) until the day it departs. This time does not include any days which the horse spends in quarantine facilities outside of the venue. The following goods and services are included in the package:

**Bedding:** A choice of three different bedding materials (wood shavings, wheat straw or shredded newspaper) will be included as part of the package. Wood shavings will be considered the default bedding unless KER is notified of a requirement for straw or paper 60 days before the horse arrives. Each stall will be pre-bedded with 10 bales of shavings (or straw or paper equivalent) and 1 extra bale of shavings (or equivalent) will be provided for each additional day a horse resides at the venue. Additional bedding above this allotment may be purchased at the venue.

**Forage:** Timothy hay will be the main forage offered as part of this package. Each horse will be allotted 11 kg/day. Other forages (alfalfa, chaff, haylage, etc.) are also available as substitutes for the timothy, but 60 day prior notice is required to reserve these products.

#### **Cereal Grains and Concentrates:**

As part of the package, each horse will be allotted 6 kg/day of cereal grain or concentrate. Cereal grains will include oats, barley, corn and wheat bran.

**Concentrates:** A range of both pelleted and textured (muesli) concentrates will be available. These feeds will be formulated to meet the nutrient requirements of the horses participating in the various WEG disciplines and will include ingredients and packaging which highlight the equine nutrition innovations from Alltech, the title sponsor of the competition.

**Electrolytes:** Both powdered and paste electrolytes will be included as part of the all-inclusive package. Other supplements will be available for purchase.

**Carrots:** Each horse will be allotted 1 bag of carrots per day as part of the package. Additional carrots above this quantity will be available for purchase.

**Consultation Services:** The nutritionists at KER will work with NFs and individual riders to determine the feeds and forages that are best suited for their horses. This will include working with team veterinarians and feed manufacturers to select feeds and forages which most closely match what the horse is commonly fed at home.

**Feed Importation Assistance:** NFs and riders may wish to bring additional feeds to the venue in addition to those provided by KER. Most commercial feeds will be allowed into the United States provided that they are accompanied by appropriate importation documentation required by the United States Department of Agriculture (USDA), the Food and Drug Administration (FDA) and state and local authorities. As part of the all-inclusive package, KER will offer NFs assistance in completing the documentation necessary for feed importation.

**Feed Shipping and Storage:** Teams in Europe that do not wish to arrange their own feed shipping to Kentucky can ship their feeds from freight consolidation points within Europe arranged by KER. Consolidation points and pricing will be published at a later date. Additionally, KER will offer a limited amount of refrigerated and unrefrigerated storage at the venue for feeds. This storage will be allotted on a first come, first serve basis to NFs that have already pre-paid deposits.

**Payment Terms:** Payment for all inclusive packages will be accepted beginning March 15, 2010. Payments received after July 15, 2010 will incur a 5% late fee. No stalls will be bedded at the venue until payment is received or special arrangements are made for late payment. Full payment for any extra purchases in addition to the all-inclusive packages will be required before the horses leave the venue at the conclusion of the competition.

**Refunds:** Full refunds will be given for any unused horse days or cancellations. These refunds will be issued by November 1, 2010.
